Northwestern College is located on the shore of Lake Johanna in metropolitan Minneapolis/St.Paul on 95 acres of woodland and well groomed campus. This facility offers hotel style residences, meeting rooms, theater, and athletic facilities including both an indoor pool and lake swimming. It promises to be an ideal location for the activities of this Second North American Linnell Family Reunion.

ecause the largest geographical group of Linnells lives in the midwest, this reunion is expected to draw an attendance of 300 or more. The Reunion Committee consisting of Bonnie and Roger Hansen-chairs, Bonnie Featherstone, Debbie Banks, Dick Linnell, Mavis and Earl Palmquist, Marvel and Marvin Soderlund, Althea and Don Tremewan and Penny Schluender have been planning a variety of presentations depicting the arrival of the many branches of the Linnell family that migrated to Minnesota in the middle of the 19th century. There will be time to share family memorabilia and pictures and to discover kin from other parts of the country.

A letter sent to 150 Linnell family members in a five-state area around Minnesota has solicited offers of help for this event. Since it enriches the experience greatly to be part of the planning and execution of a reunion, the committee is anxious to have the participation of all who can share in the event. LINNELL SCHOOL SITE IN MINNESOTA IS HONORED



The LINNELL SCHOOL of Becker Co., MN, as well as the Linnell Cemetery and Post Office, is being honored at the centenniel celebration of Pondsford, MN on July 7-8, 1990. A memorial plaque has been designed by Roger Hansen to be placed at the Linnell Cemetery and carries this picture of the Linnell School.

The Linnell School will play a special part in the celebration. A committee of those who attended this school has been working on this part of the commemoration. Original records of student achievement will be copied by a copier; or if records are found to be too brittle to handle, they will be recorded by hand. Other memorabilia will note highlights of the school over the past one hundred years.

The Linnell School was opened in the fall of 1890 in a log building, perhaps on the property of Abby Linnell. In the spring term of April 18, 1891 there was a smaller enrollment than the previous fall because the larger boys were engaged in farm work. The above pictured school met the growing needs of elementary students of the area until 1956 when they were included in the school districts of Park Rapids and Detroit, MN. This building has since been torn down.

A parade on July 7, 1990 at Pondsford will include a banner carried by members of the Linnell Association. Members who can participate should call Bonnie and Roger Hansen, 612-786-3606 for details. The day will also

include a sheep auction such as would have been held in olden days, native-american features that includes an India pow-wow and a dance in the evening. Sunday, July 8, will be an open day with a picnic. But of special interest to Linnells will be the dedication of the Linnell Commemorative Plaque at the Linnell Cemetery in the afternoon. Press and photographer coverage will provide pictures of this event for the Linnell Association at our reunion.

While some Linnells supported education by political action and grants of land, other Linnell descendants taught in Minnesota schools in those early days.

In Detroit, MN, in the same Becker County where the Linnell School is located, Mary Belle Linnell (117,612,123,1 p. 357 D.R.L.) taught science in the high school in 1916-1918, her first teaching contract. This same person, Mary B. Linnell, is pictured in the introduction to the Descendants of Robert Linnell*. Her genealogical spadework served as an early start for our family history.

Another early school at Mineral Center, MN was the Birchwood School, founded in 1911. Some of the children of Peter M. Linnell were among the original 11 students. They were taught by Blanche Woodard. This school continued in operation until 1938 when the entire block of land comprising Mineral Center was sold to the government to enlarge the Indian Reservation there.

The last teacher of the Birchwood School was Gertrude (Peterson) Linnell, daughter of Blanche Woodard and wife of Arnold U.Linnell (118,241,116,59 p. 231 D.R.L.) Even in that final year this remained a one-room school for grades 1 through 8. Students from as far away as four miles attended. The school was heated by a wood-burning stove with a tin jacket. Gertrude and her mother did their own janitor work. Students helped to carry water from a nearby spring.

Gertrude married Arnold Linnell in 1939. She continued to teach the mid-elementary grades at Grand Marais, MN., with one year's absence in Montana in 1954-55, until her retirement in 1976.

Other early Minnesota teachers will be recognized in the next Newsletter.



ROBERT LINNELL to Discover
More of Your Ancestry.

Many living Linnells and Linnell descendants can claim that their ancestors came over on the Mayflower in 1620. One such ancestor was Stephen Hopkins whose family was the largest on board the Mayflower. It included his second wife Elizabeth and his children: Constance, Giles, Demaris and Oceanus who was born at sea. And there were two servants:

Edward Doty and Edward Leister. It is obvious that Stephen Hopkins was clearly dedicated to living in the New World. He had already made one trip to Virginia in 1609 and had returned to London to gather his family for the next opportunity to settle here.

Two great, great granddaughters, Sarah and Thankful Hopkins, are the links to Linnell descendants. Sarah and Thankful are of the 5th generation Hopkins family and were the children of Stephen(4) and Sarah (Howes) Hopkins, Stephen(4) was the son of Stephen(3) and Mary (Merrick) Hopkins. Stephen(3) was the son of Giles(2) and (Catherine Wheldon) Hopkins. And Giles(2) was the son of phen(1) Hopkins. Both Stephen(1) Hopkins and his son Giles(2)

were passengers on the Mayflower.

There are two additional generations from great, great granddaughter Sarah(5) to the Linnell lines. The son of Sarah(5) (Hopkins) and Jonathan Cobb was Eleazer Cobb. Eleazer and Keziah (Crosby) Cobb had a daughter, Lydia Cobb, who married Samuel Linnell (11a,b16 p. 94, D.R.L.) on 29 Nov. 1787. This confirms that all of you whose genealogical code number begins with 11a,b16 are descended from Stephen and

Giles Hopkins of the Mayflower.

Thankful, sister of Sarah, married Thomas Linnell (117,6 p. 16, D.R.L.) on 6 Oct. 1726. Thus all descendants of Thomas and Thankful (Hopkins) Linnell and whose identification numbers begin with 117,6 are also descendants of Stephen and Giles Hopkins of the Mayflower.

And don't despair if your number hasn't been included here. Future issues of the Newsletter will trace descendants of William Brewster and Thomas Paine. Meanwhile we keep searching for other Mayflower ancestors, welcoming clues and questions from readers about this lineage.

HAVE YOU PAID YOUR ASSOCIATION DUES?
