#### Attention: All high school seniors and current college students!

We invite you to apply for award of the <u>Linnell Family Association 2013</u> <u>Scholarship Fund.</u> Any high school senior or current student of a college or an accredited higher education program, and who is a descendant of Robert Linnell, is eligible to apply for the scholarship.

#### How do students apply?

Student applicants are asked to write an essay on Linnell family history or current positive influences of the Linnell family. The essay should be typed and double-spaced, not less than 1,000 words, nor more than 2,500 words in length.

One winning essay will be selected this year for the <u>\$1000</u> scholarship award.

Students should mail their original essav along with: the LFASF Scholarship Application form; two letters of recommendation (one from a teacher of the applicant and one from a member of the applicant's community); and a current academic transcript.

If you see 'xx' in the "Last Year Paid" position, it means the LFA records are incomplete and do not indicate the last year you paid your membership dues. On the mailing label example, Decedents R. Linnell is a "Annual Dues" member and last paid in "2012".

To receive a hard copy of the LFA Newsletter, you will need to be a Life member or have paid Annual dues in the last three years.

### **Article from Rachel Linnell Wynn**

#### In Memory of Drusilla Ruth Hickisch Linnell Wife of Richard "Dick" Linnell

Drusilla Linnell was the wife of Richard, Dick, Linnell, and supported his many, many efforts in the development of the Linnell Family Association from its earliest days.

My first meeting with this couple came in the early 1980s when they arrived at the Wynn home in Rochester, NY to find out what Rachel Wynn had in mind in developing a history of the Linnell family. There, in the next 48 hours, the Linnell's and the Wynn's melded; finding their relationship, securing their history, comprehending their 400 years of common family history. It was where Dick signed on to become part of the effort to form a Linnell Family Association.

And Dru and Rachel's husband J.C. became the support for this effort from the beginning.

Dru and Dick invited me to stop with them at their lovely colonial home in Illinois in 1983: when I was still gathering data for the first publication of DRL in 1988. How hospitable they were! And how they both gave support for the gathering of supportive data for the publication! Dru even found interest in adding to the records of the Hickisch family too.

But it was her dedication to Dick's drive to gather his part of the Linnell history that took them on expeditions into the Minnesota **and** Wisconsin areas for direct meetings with cousins that viewed long remembered school houses and farm locations. Dick, with Dru's support, could bring to light stories and family tales that affirmed the telling of the Linnell story.




Dru backed Dick's efforts from the beginning and provided warmth and patterns of human effort that made connections possible. Dru helped create displays of historical material and "for sale" items to support the budget.
