LFA SCHOLARSHIP FUND GOES TO VIDEO

The Linnell Family Association Scholarship Fund is expanding its parameters for those wishing to submit an application for the award of college tuition funds.

In prior years, the rules for the scholarship award called for the presentation of a written essay. This criterion is now being expanded to give applicants the choice of submitting a written essay or a video presentation on their own Linnell family history or current positive influences of their Linnell family. The guidelines for the new LFASF are being finalized at this time, so be sure to watch for further guidance in both the LFA newsletter and on the LFA website. The selection of the winner and the award of the scholarship funds will be announced in conjunction with the upcoming 2022 LFA Reunion scheduled for June of 2022 in Hyannis, Massachusetts.

LINNELL FAMILY ASSOCIATION SCHOLARSHIPS How To Apply

We are pleased to invite Linnell family students to apply for the Linnell Family Association scholarship. The Linnell Family Association Scholarship Fund was established in 2000 with a donation of \$500 and has continued to grow in value over the years. The next scholarship of \$1,500 will be awarded in 2022.

Who Can Apply?

Any descendant of Robert Linnell who is college or accredited higher education program bound or is a current student of a college or accredited higher education program is eligible to apply for the scholarship. Applicants must submit a written an essay or create a video presentation about Linnell family history or about the positive influences of a living Linnell family member. Essays must be between 1,000 to 2,500 words in length, typed and double-spaced. Video presentations must be between 5 minutes to 15 minutes long. One winning essay or video presentation will be selected in 2022 for the scholarship award. **Deadline for submission is April 30, 2022.**

How do I share my video?

Applicants wishing to enter a video presentation for the LFA scholarship award can do any of the following:

- ⇒ Upload your video to a private YouTube channel and share the link to the video; or
- ⇒ Upload to an online cloud service, like OneDrive or Google Drive and share the link to the video.

When Are Applications Due?

Applications, accompanying essay or video presentation, letters of recommendation, and most recent school transcript must be submitted by April 15th of the award year. The next scholarship will be awarded in 2022.

How Are Essays/Videos Judged?

The Linnell Family Association Scholarship Fund Administration Committee (LFASFAC) will oversee the selection and judging of all scholarship award applications based on content and clarity of expression.

RULES AND PROVISIONS GOVERNING

THE LINNELL FAMILY ASSOCIATION SCHOLARSHIP FUND (LFASF)

- 1. **Scholarship Awards**: Award(s) of \$1,500* will be offered to descendants of Robert Linnell for use in a college or accredited higher education program.
- 2. **Eligibility**: Open to descendants of Robert Linnell who are college or accredited higher education program-bound individuals or are current students of a college or accredited higher education program.
- 3. **Award Cycle**: LFASF awards shall be awarded in the year of the LFA national reunion or at times designated by the LFA Steering Committee.
- 4. **Application Requirements**: A written essay of 1,000 to 2,500 words in length or a 5- to 15-minute video presentation involving the history or current positive influences of your Linnell Family. (See also **Essays/Video presentations** below)
- 5. Applicant's most recent academic transcript is required.
- 6. Acceptance to or attendance in a college or accredited higher education program must be verified.
- 7. Two letters of recommendation shall be submitted with each application one from a teacher of the applicant and one from a member of the applicant's community.
- 8. **Application Deadline**: Applications and accompanying essays or video presentation must be submitted to the Linnell Family Association Scholarship Fund Administration Committee (LFASFAC) by April 15 of the award year.
- 9. Award Dates: Winner(s) will be notified in writing not later than June 1 of the award year.
- 10. **Awards Payable To**: All LFASF awards will be made payable to the appropriate institution upon completion of one semester, which semester must be completed within three years of LFA Scholarship award, at which time unawarded funds will be returned to the LFASF.
- 11. **Scholarship Amount**: The amount of any award is based on a minimum of one scholarship per award cycle for each \$1,500 of funds in the LFASF, with the number and amount of scholarship(s) awarded not to exceed 33% of the total amount of funds in the LFASF during the award cycle (*unless authorized by the LFA Steering Committee).
- 12. **LFASF Administration Committee**: The LFASFAC shall be comprised of three members appointed by the Linnell Family Association President, with approval of the Steering Committee, and will serve as the judges of any submitted scholarship applications and scholarship award. (See the LFA website for LFASFAC members.)
- 13. **Funds**: All funds donated to the LFASF will be administered by the LFA Treasurer and maintained in a separate account. Such funds will be invested as recommended by the current Association Treasurer with the approval of the LFA Steering Committee.
- 14. **Essays/Video presentations**: Each essay shall be 1,000 to 2,500 words in length and shall be typed and double-spaced; or, each video presentation shall be at least 5 minutes and no longer than 15 minutes in length. Consideration will be given to content and clarity of expression.
- 15. **Judging Criteria**: Judges will consider the relevance of each essay or video presentation in terms of content and clarity of expression of Linnell family history.
- 16. **Retainage**: The LFA will retain exclusive rights to all essays/video presentations submitted.
- 17. **Amendments:** Any proposed changes or amendments to the foregoing rules and provisions shall be approved by the Steering Committee and referred to the LFA by newsletter or other publication for active member comment.

LINNELL CONTRIBUTION TO THE ADVENT OF THE U.S. COAST GUARD

At the last reunion on the Cape in 2015, we honored Captain Ebenezer Harding Linnell of the clipper ships Eagle Wing and Flying Mist. While doing research on E H Linnell, we discovered a rich heritage of Linnell contribution on the Cape to lifesaving. Lifesaving on the Cape dates to the winter of 1626-1627 and the wreck of the Sparrowhawk, a Mayflower era ship carrying passengers bound for the New World which wrecked near modern day Orleans. Aid was first provided by Native Americans, who notified the colonists at Plymouth. William Bradford, governor of Plymouth Colony, personally led a rescue mission which brought much needed supplies. The survivors were ultimately taken to Plymouth, and remarkably, no deaths were recorded for this first lifesaving mission.

The first organization to provide relief to shipwreck victims was the Massachusetts Humane Society (MHS), which was founded in 1786 and incorporated in 1791. The purpose of the Society in part was for the recovery of persons who meet with such accidents as to produce in them the appearance of death, and for promoting the cause of humanity, by pursuing such means, from time to time, as shall have for their object the preservation of human life and the alleviation of its miseries. Years later the Society built the first lifeboat station in Cohasset. There were soon at least four stations on Cape Cod; in Provincetown, Eastham, Chatham, and Orleans. Eventually, in 1847 the federal government took the step of providing money for lifeboats to be stationed at lighthouses creating the US Life-Saving Service (USLSS) in 1848. However, the lifeboats and equipment were lost, misused, and stolen. In 1854, after a terrible storm, the first professional "keepers" of the lifesaving stations were appointed in 1855.

Ineffectiveness of the federal government in supporting lifesaving operations continued in part due to neglect during the Civil War. After another terrible storm, Sumner Kimball Chief of the Treasury Department's Revenue Marine Division in 1871 studied the problems plaguing the lifesaving stations. He obtained an appropriation from the US Congress to make improvements. Kimball's efforts resulted in nine federally funded lifesaving stations on Cape Cod in 1872. The US Lifesaving Service (USLSS) was separated from the Revenue Marine Service a few years later and continued as an independent agency under the Treasury Department until the US Coast Guard was established in 1915.

Our Linnell family is directly tied with the lifesaving station at Orleans. Captain Dean Gray Linnell, served as the Keeper for the Humane Society hut in Orleans under the auspices of the USLSS and led volunteers. One of his notable rescues was the wreck of the Orissa on January 18, 1857. Solomon Linnell was one the first keepers elevated to Captain in 1871 and jointly discovered the remains of the Sparrowhawk some years earlier.
